This agreement will expire after 6 months from the date this has been signed. Upon expiration of this agreement, a reinstatement fee may be charged before any further services are provided.

From here on "Bick's" shall be referred to as "The Driving School" and the student signing will be referred to as "The Student".

The Driving School shall provide a Licensed Instructor and a Motor Vehicle for instruction but **Does Not Guarantee** the issuance of a Driver's License to The Student.

The Driving School reserves the right to cancel this agreement at any time, should The Student's conduct indicate a lack of responsibility deemed necessary by The Driving School to safely operate a motor vehicle. Destruction of property, or the possession, distribution, or use of any tobacco product, alcohol, or drug of abuse is strictly prohibited.

The Driving School shall furnish a certificate of completion to all students under the age of 21 years, who successfully complete the course. Completion, as defined by the State of Ohio, refers to the completion of the required number of hours, the student's good faith effort having been exercised during the practical driving portion, and the attainment of a score equal to or greater than 75% on the performance measurement. Should The Student fail to achieve the minimum passing score on the final exam additional classroom attendance may be required.

A fee of \$100.00 will be assessed for:

- Giving less than **24 hours'** notice to cancel an in-car lesson. Notice for Monday in-car lessons must be provided by 12:00 PM on the Saturday prior to your scheduled lesson (the school is closed **on Sundays**). Exceptions for sick notes from a doctor or urgent care. Must provide proof of care to be excused.
- The Student must arrive for instruction free from the odor of marijuana.
- Failure to appear for a scheduled driving lesson.
- Failure to bring your Temporary Driver's Permit for a scheduled driving lesson.
- Failure to pay your remaining balance one business day before your first scheduled driving lesson. All scheduled driving will be subsequently canceled and rescheduled once payment is received in full.

Remaining balance _____ is due one business day before the first in-car lesson.

A \$20 fee applies to returned checks. There are no refunds and a \$15 fee applies for replacement certificates.
