This agreement will expire after 6 months from the date this has been signed. Upon expiration of this agreement, a reinstatement fee may be charged before any further services are provided.

The Driving School shall provide a Licensed Instructor and a Motor Vehicle for instruction but **Does Not Guarantee** the issuance of a Driver's License to the student.

The Driving School reserves the right to cancel this agreement at any time, should the Student's conduct indicate a lack of responsibility deemed necessary by The Driving School to safely operate a motor vehicle. Destruction of property, or the possession, distribution, or use of any tobacco product, alcohol, or drug of abuse is strictly prohibited.

The Driving School shall furnish a certificate of completion to all students under the age of 21 years, who successfully complete the course. Completion, as defined by the State of Ohio, refers to the completion of the required number of hours, the student's good faith effort having been exercised during the practical driving portion, and the attainment of a score equal to or greater than 75% on the performance measurement. Should Student fail to achieve the minimum passing score on the final exam additional classroom attendance may be required.

A fee of **\$100.00** will be charged for:

- Giving less than **24** hours' notice to cancel a driving lesson. Notice for Monday lessons must be provided by 12 PM on Saturday (the school is closed **on Sundays**). Exceptions for sick notes from a doctor or urgent care.
- Failure to appear for a scheduled driving lesson.
- Failure to bring your Temporary Driver's Permit for a scheduled driving lesson.
- Failure to pay your remaining balance before or on your first scheduled driving lesson. All scheduled driving will subsequently be canceled.
